### California Resident Privacy Policy Rights

Consumers may contact HCE-NA to exercise any of the rights granted under the CCPA regarding their personal information. HCE-NA will respond to a verifiable consumer request within forty-five (45) days of its receipt. If HCE-NA requires more time (up to ninety (90) days), HCE-NA will inform you of the reason and extension in writing.

There is no fee for reasonable requests. However, we reserve the right to charge a reasonable fee for requests that are manifestly unfounded, excessive, or repetitive.

Please note that these rights apply only to select California consumers and exclude applicants, employees, and business contacts. Only you, or a person registered with the California Secretary of State that you authorized to act on your behalf, may make a verifiable consumer request related to your personal information.
